Any vendor participating in the Aransas Pass Farmers Market/Trade Day must agree on the following provisions, by signing below:

1. Aransas Pass Farmers Market/Trade Day reserves the right to remove any vendor or item in violation of the regulations set forth.
2. The undersigned agrees to defend, indemnify, and hold harmless the Aransas Pass Farmers Market/Trade Day organizer/s, from and against all liabilities, claims, suites, or demands for injuries to any person and/or property arising out of the undersigned's participation in such activity. The undersigned further agrees to assume all financial responsibility, including but not limited to damages to property or injuries to persons, arising out of vendor's participation in Aransas Pass Farmers Market/Trade Day.
3. **NO VENDOR** shall sell any illegal items or items that infringe upon registered trade marks.
4. **NO Fireworks or explosives** of any kind may not be possessed or sold. Products deemed judged unacceptable will not be allowed.
5. **No alcohol** allowed.
6. All **animal vendors** must abide by the Animals Welfare Act which provides for, but is not limited to, exercise of the animal enclosure guidelines; and providing adequate food and water. (Animals must be caged or leashed. A box is not considered a cage.)

Additionally, all **animal vendors** are prohibited from tethering any animal to a stake or tree; allowing any animal to eliminate on the grass courtyard, and, the vendors must retrieve and properly dispose of any fecal matter eliminated by their animals.

7. All **food vendors** must possess on premises a permit issued by the Texas Department of Health.
8. **Clean Up:** It is every vendor's responsibility to ensure your area is clean and orderly before leaving.
9. **Hours of Operation:** Vendors may begin on-site set up no earlier than 7am. Vendors are asked to be open for business by Market Open at 9am, and completely vacated from the premises no later than 2pm.
10. I have read the rules and regulations of the Aransas Pass Farmers Market/Trade Day above and agree to abide by them.
