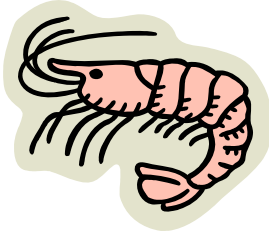


**60TH ANNUAL
OFFICIAL SHRIMPOREE OF TEXAS
2008 POSTER CONTEST – ENTRY GUIDLINES**



1. There is no theme for this year's entries. All artists' entries will be given FULL consideration.
2. Release of rights: Each artist will be asked to sign a release of all production rights to the entry at the time of delivery to the judges committee.
3. Each piece of work must be completed, signed, original and ready for reproduction.
4. Your artwork should be unframed and formatted to allow a poster reproduction measuring 20" x 30" in a vertical or horizontal rendition. This will allow for maximum exposure of the artwork in the poster. No photo art or reproduction art will be accepted.
5. Deadlines:
 - a. All original pieces of artwork must be submitted to the Aransas Pass Chamber of Commerce at 130 W. Goodnight in Aransas Pass, Texas by no later than 3:00 p.m. on **April 1st**. Each entry **MUST** be delivered with a dust cover, and you may provide an easel.
 - b. Artwork to be provided on CD disk in a jpeg format.
 - c. Poster committee to make final selection on **April 4th**.
 - d. All original pieces of artwork must be picked up at the Aransas Pass Chamber of Commerce no later than 3:00 p.m. on **April 18th**.
 - e. A committee selected by the Aransas Pass Chamber of Commerce Board of Directors will judge entries. No artists, relatives of artists or an employee of an artist or anyone associated with artist in a manner that will cause a conflict of interest shall be appointed to the Judges Committee.
 - f. The winning artist will be notified upon arrival to pick up their artwork.
6. The Aransas Pass Chamber of Commerce will advertise and hold a reception and Signing Party for the selected artist on: a date to be determined with completion of printing of posters. The reception will be done prior to Shrimporee '08.
7. The winning artist will receive 100 copies of the finished poster for personal use.
8. The winning artist will receive the original artwork for personal sale.

NOTE: Failure to follow these guidelines will result in disqualifications of the artist from the contest. Any questions should be addressed to the Chamber of Commerce, 361-758-2750.

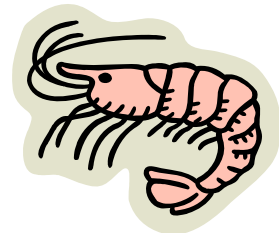

Contract with Aransas Pass Chamber of Commerce

Aransas Pass Chamber of Commerce ("Chamber") has acquired from _____
("Artist") the right to reproduce a painting entitled _____ ("the work") upon the
following terms and conditions.

- (1) The artist hereby grants to Chamber the exclusive right throughout the world to publish, manufacture, advertise, distribute, and sell reproductions of the work ("the reproduction").
- (2) Each reproduction shall be approximately 20 x 30 in size and postcard size.
- (3) In consideration of hereof, the Chamber shall provide to the artist 100 copies of the work as reproduced by the Chamber for the use in the 2008 Shrimporee Festival.
- (4) Each reproduction will carry a legend indicating the name of the artist.
- (5) The ownership of the copyright in the reproduction shall at all times reside in the Chamber and the ownership of the copyright in the work shall at all times reside with the artist.
- (6) The artist warrants originality, authorship, and ownership of the work; that the artist has the power to enter into this agreement; that neither the work nor the reproduction has hereto been assigned, licensed, and transferred; and that the use or publication of the reproduction by the Chamber will not infringe upon any copyright, propriety, or any other right of any third party. The artist agrees not to authorize others to use or publish the work or the reproduction.
- (7) This agreement is to continue in effect for the term of the copyright on the reproductions.
- (8) This agreement contains the entire understanding of the parties and shall be construed under and in accordance with the laws of the state of Texas.

Please confirm that the foregoing accurately and completely sets forth our entire understanding by signing and returning the enclosed copy of this letter.
