Please read the following letter carefully for information and details pertaining to entry.

The parade will be held Saturday, June 13th, 2020 at 10:00 am. The parade will begin at the intersection of East Maddox Ave. and Commercial Street and end at DeBerry Avenue. Participants are asked to line up on Stapp Ave. turn right onto Huff (Harbor) take a right onto Maddox Ave. to line up. Parade will start as you go left onto Commercial St. For your convenience, a map of the parade route is included with this letter.

Judging will take place at 9:00 am. Everyone is asked to be prepared and on time; being late may result in not being judged. Marching groups will be given 1-2 minutes to show their formation. Appearance of all participants will be taken into consideration. Midway through the parade, winners will be announced from the Judge's Booth and you may claim your trophy. Judging categories are as follows:

**1<sup>st</sup> Place Only**

- Best of Show
- Best of Spirit
- Best Decorated Float
- Judge's Award: Best Overall Entry
- Best Theme
- Best Youth Entry
